# RICE TOWNSHIP BOARD OF SUPERVISORS - MINUTES May 5, 2020

Arnold asked Secretary Beck to poll attendees on the conference call. Along with Pipech and Smith, Andrew Pasonick, John G. Dean, Esq., Mark Manosky, Pat Rushton and Rebecca Sodergren attended by conference call.

**PUBLIC COMMENT:** Planning Commission member Mark Manosky asked if Atlantic Broadband was going to follow up with the pave and driveway cuts there. He also asked that they restore his front yard to the condition before their digging. Arnold asked Beck to follow up with Atlantic Broadband.

**ENGINEER'S REPORT:** Pasonick reported that Brdaric Excavating, Inc. was the low bidder for the demolition of the fire hall at \$28,600. He recommended awarding the bid to Brdaric. He also noted that the fence had been installed for the pickleball court.

Solicitor Dean was concerned that an easement may or may not exist based on the Jennifer's Way plans and counseled tabling the issue until clarification was received. The stop work order on the Jennifer's Way project remains in force until sewer clarity is reached.

Arnold noted that the Planning Commission met on April 24th at 7pm. and draft minutes are available to the public, and the Wright Township Volunteer Fire Company Report & Fire Police Incident Recap will be reviewed at the June meeting.

SOLICITOR'S REPORT: Dean noted that there was nothing to report beyond the Jennifer's Way issue.

PUBLIC COMMENT: Bruce Fine questioned the reasons to table the Gallagher subdivision since the buyer of that property would grant him the sewer easement. Pasonick expressed his concern that all of his comments on the Gallagher subdivision had not been met. Dean noted that a plan for sewer connection for Jennifer's Way did not exist. Fine replied that he had a plan, but the March Planning Commission meeting was canceled and he did not know that the April meeting was held. Dean and Arnold replied that no written plan has been presented to the Township and conversations outside of the Planning Commission meeting does not solve the problem. Fine thinks that he should be able to continue construction while he works this out. Dean noted that no fact

exists to take sewage from the property and that the lack of a written plan is not immaterial. The stop work order must remain in place until a written plan exists. Fine threatened to sue the Township for attempting to take away the preliminary approval for Jennifer's Way. When Fine offered that he could off-load sewage through Mountaintop Village (Village), Arnold referenced the letter from the Mountaintop Village Homeowners Association (HOA) Board letter which states that they must approve any easement across Village property and the HOA will not grant such an easement for Jennifer's Way. While Fine said that was wrong, Arnold noted that would be a civil matter between Fine and the HOA and the Township would wait for the result of any such litigation. Arnold and Pipech concluded that there must be a written plan solution presented to the Township. Fine agreed that he will work to settle this issue.
