The duly advertised regular meeting of the Rice Township Board of Supervisors was held on Tuesday September 7, 2021, at the Rice Township Municipal Building, 3000 Church Road, Mountaintop. Copies of the Agenda, draft minutes of the previous meeting and Treasurer Reports were available to the public. Chair Robert Pipech called the meeting to order at 7:00 p.m. It was announced that the meeting was recorded for preparing the minutes. Interior cameras were also recording the meeting.

The Board of Supervisors held an executive session on August 24, 2021 and September 2, 2021 to discuss personnel matters.

ENGINEER'S REPORT: Engineer Andy Pasonick reported that the 2020 Pave Project was complete and recommended payment to New Enterprise. Pasonick then explained that DEP wants the Ice Lake Dam sluice framing removed, power washed and video pictures taken to determine the structural condition of the sluice. While DEP has not made any final decision, but it appears that DEP supports using the sluice and the 14"pipe as the dewatering mechanism to meet the legal requirement. During the work, Pasonick explained that the outside of the dam, both streamside and downstream will be repaired with shotcrete and the spillway repaired with concrete. Pasonick also reported that the County Bridge on Heslop Road was down to one lane and that communication was taking place with the County. Residents Biggs, Manosky, Miller and Mateo all expressed concern about the damage to the bridge. Pipech added that the proposed secondary access road from the upcoming Woodberry PRD would solve the safety issue and asked Beck to pursue funding from Cartwright's office. Arnold clarified that the bridge was owned by the County and we could not initiate any repairs, but were communicating with the County to get the repairs made. Biggs also complained about a blocked stormwater pipe at the foot of the northern leg of Wilderness Drive. Resident Wojtowicz from Nuangola Ave. complained about stormwater flooding his property.

payments required by the grant for the pickleball court. Beck pointed out the two \$50,000 offsetting entries on page two because of the funds required for the Pave Project payment, pointing to that payment on page 3. Referencing Actual versus Budget, Beck pointed out that tax receipts were well above budget and last year's actuals and pointed out the \$185,000 representing ARPA restricted funds. Beck concluded that the current surplus in the General Fund was about \$80,000. Beck noted the Pave Project payment out of the Liquid Fuels fund and the payments to Barry Isett for soccer field preliminary work which will be reimbursed by the grant. Beck concluded with bank balances as of 8/31/2021; General Fund balances totaled \$590,215.77; Liquid Fuels balances totaled \$203,114.41; Recreation Fund balances totaled \$13,253.22 of which \$385 are restricted donations for a new pickleball court, all for a total of \$806,583.40 cash on hand. Restricted balances include \$500.08 in the DCNR grant account, \$5,002.31 in the Developers' Escrow Account and \$185,578.51 in the ARPA account for a total of \$191,116.24 of restricted funds. Discussion with Arnold and Smith concluded that no action should be taken regarding ARPA funds until final guidance is received from the US Treasury. MOTION by Smith, second by Pipech, to accept the Treasurer's Report as presented, and all bills to be paid. ROLL CALL: Arnold - yes Pipech - ves Smith - yes

Pipech announced that Tropical storm Ida severely impacted Rice Township on September 1, 2021. Nuangola Road, Henry Drive, and Aleksander Boulevard were closed due to flooding conditions. A section of Prospect Road was taken down to one lane. Ten families in Valley Stream were evacuated due to the flooding. The County bridge on Heslop Road was flooded and is seriously damaged. That bridge is now reduced to one lane. The experience with this bridge merely reinforces the current plan to build a secondary access to Heslop Road as the Woodberry PRD is constructed; other stormwater issues exist throughout the Township. The Roadmaster and Township Engineer are currently reviewing those issues to determine those that can be fixed and the cost and process to do so. Some of the ARPA funds may prove useful for these repairs; the 2021-2022 recycling stickers have arrived. Residents may obtain their sticker by turning in their 2020 recycling permit to the office. Call 570-868-6400 option 1 with any questions; The Ice Lake Park has reopened for the summer until dam construction resumes after the Department of Environmental Protection grants permission to complete the project to their specifications. Note the new signage at the park. Boats must stay away from the dam construction site; Luzerne County is offering free tire collection on Saturday, October 9<sup>th</sup>, 2021 at the Hanover Area Jr/Sr/High School at 1600 Sans Souci Parkway. Flyers are available at the Township Office and is posted on our website; and the Planning Commission met on August 25, 2021 and draft minutes are available.

Wright Township Volunteer Fire Company Report & Fire Police Incident Recap. Arnold reported that response occurred to 60 emergencies and the Fire Police responded to a number of issues. Arnold thanks the first responders for their dedication.

**SOLICITOR'S REPORT:** There was no report.

**PUBLIC COMMENT**: Developer Bruce Find delivered a proposal for a change in the drainage for Jennifer's Way and the matter was referred to the Planning Commission.
