MINUTES

October 28, 2020

The duly advertised regular meeting of the Rice Township Planning Commission was held on Wednesday, October 28, 2020 at the Rice Township Municipal Building, 3000 Church Road, Mountaintop. Arnold called upon Lang to present the request to recommend final approval for the land development plans for Dollar General. Those conditions being met – receipt of the NPDES, HOP and DEP sewer module permits – triggers the request for recommendation of final approval of the land development plans. Arnold asked Engineer Pasonick if all his comments had been addressed and Pasonick replied in the affirmative, noting that two of his issues were no longer applicable.
